i. AB—15 Rep. Brown, UDEBATE, -- \$3,947

1. Presentation

- a. Brown
 - i. Only request this club will make all year.
- 2. Questions
 - **a. Bond:** Why spending so much?
 - **b. RSO:** hosting several prestigious associations at this tournament. Hosting over 300 people who we are expected to feed. Partnering with the JRP debate society for this championship. Representing the school and representing them.
 - **c.** Maughan: have you been able to fundraise at all for this event?
 - **d. RSO:** since we are a sponsored group, we have not been able to fundraise.
 - **e. Bond:** were you able to get funds from the COH?
 - **f. RSO:** the COH is funding part of it but not all of it.
 - **g.** O'Leary: is there an attendance fee for schools?
 - **h. RSO:** they are paying the the Qatar Debate foundation for housing. But, we are not getting paid anything by Qatar Debate.
 - **i. Subotic:** you are using student fees to fund Stanford university student food?
 - j. RSO: we are funding a student debate championship.
 - **k.** Subotic: who will be eating this food?
 - **l. RSO:** not U of U students.

- **m. Subotic:** under University of Utah guidelines, this is not eligible for funding. We cannot fund for anything consumed by non-Utah students.

- ii. AB 20 Rep. Burke, Bangladeshi Student Association (\$667.10)
 - 1. Presentation
 - a. **Burke:** The BSA is requesting reimbursement for a cricket tournament over the summer. There were 36 participants (students). The costs included materials utilized at the tournament, food, and trophies. Trophies were retained by individuals, not by the group, which could be amended in the bill.
 - 2. Questions
 - a. Kotter: No clarification on cost of trophies?
 - b. **Burke:** does not know the individual cost.
 - c. **Munot:** why is there an issue with trophies?
 - d. **Burke:** The trophies are counted as gifts. If we can fund t shirts, we should be able to fund the trophies.
 - e. **Locke:** would it be possible to send a follow-up? Can we table this bill?
 - f. **Burke:** I think it is beneficial to table this bill.

- iii. AB 21 Rep. Burke, Asian Pacific American Law Students Association (\$1,500.00)
 - 1. Presentation
 - a. **Burke:** For the Lunar New Year celebration. The APALSA held this event last year, with food catered from a local restaurant. This totaled \$1,500, so they are using it as a point of reference and asking for the same

amount. I specificed this amount must be used for catering, and nothing else.

4. Presentation

a. **Burke:** want 1500 for an event in February. They got back to me about catering but they are not sure yet. I said it would be harder to pass and they are aware of that, they will try again later until this is funded. They want \$1500 in catering and they are only supposed to use that for catering. They expect 250 law students and 8 attorneys. This event is good for networking. They used all the food last year, and leftover food was saved for the law school kitchen. They could use this event as a fundraiser.

 - 1. Presentation

a. **Barlow:** Management Consulting Club is a club within the business school, helping them prepare for jobs in the consulting industry. They get to hear from alumni in the field and help plan events. They have requested branding services and marketing, i.e. t-shirts, notebooks, and posters for tabling events. They want to increase club awareness and popularity. With guest speakers, they want to have food available. They have 45-50 students attend all meetings. They also requested club officer jackets.

 - a. **RSO:** PA students introduce bill. Get funding for jackets for our class. Class size of 69 students. It is a highly known PA program across the country and it is highly competitive. Take a lot of pride in the program. We ask for funding because of pride in the program, and representation for the community as we provide care. Migrant farms, reservations, etc. the idea of the jacket is to represent our program and community. We will be wearing the jackets for two years.
 - b. **Cerynar:** all of the clinics and events are listed on the whereas clauses. 69 jackets.

 - d. RSO: no. this is half the price of the jackets themselves. We are saking for funding because there are a lot of students who cannot pay for these jackets. It would be paid out of pocket. Grad school is expensive as is. We are trying to be inclusive as is. We are not hand picking people who cannot afford it. Pas cannot work.

- n. **Cerynar:** will you be using 3D printers at the U? How large are you printing?
- o. **RSO:** we can print at the library for free, but what we are aiming for is another printer. Top of the line if we provide our own filament. They can print fairly large.

AB 61 – Rep. Bond, ASUU Suggestions Box Joint Legislation (\$19,500.00)

1. Presentation

- a. Oleary: joint piece of legislation sponsored by ECAB and the legislature. The idea for these boxes is to put them in high traffic and visible places on campus. We want to put them in visible, high traffic places on campus. UVU has a successful system in place, as do most schools. We want a more systematic way to collect student feedback and increasing the visibility and representation of ASUU. This bill passed senate unanimously. The funds will be pulled from the general reserve and from the ECAB budget, not from the assembly contingency fund.
- b. **Bond:** to touch that money, we need assembly and senate approval. WA, the U has 34,000 students, and 13% of students voting in ASUU elections means most student voices are not being heard; WA, elections at UVU experience much higher student turnout; WA UVU has a much higher student attendance than the University of Utah; WA undergraduate students commute in higher amounts than the U of Utah; WA when compared to a Utah school of a similar size, if not larger, where none reside on campus, the U of Utah falls behind by about 7% with their student government elections; but they have physical student government suggestion boxes. WA UVUSA has physical suggestion boxes they want to add to their campus. They have QR codes on their boxes. They have assignments to their legislative counterparts that are checked once per week; ASUU must increase avenues of student communication with the rest of the school to increase trust with the school; the implementation of suggestion boxes will allow ASUU to address and implement changes according to student will; this will increase trust in student government at the U of Utah. Large campus, means ASUU must increase its presence beyond what its small office occupies. Physical tabling can only operate for relatively small windows of time; tabling means we can gather student opinions for longer windows of time; it will be a great asset to the existing data gathering tools. This will allow for easier collaboration with canpus partners. The worst case cost for constructing a box is a waste of \$435 per box. The estimated total cost of in-house production for 27 boxes is \$11,745. WA the estimated cost for a box at UVU is \$400 plus branding, which amounts to over \$500. WA the purchase of an identical UVU box would also result in less control over the form and function of the box. The timeline for these boxes and construction is about 8 weeks. The executive cabinet has already pledged \$6,000 from the presidential operating budget. TBIE, \$13,000 for the implementation and allocation for the construction of ASUU suggestion boxes. The 17 colleges will each have 1 ASUU suggestion box installed in their college. Other boxes will be distributed to increase student interaction. TBIFE, members will be represented on a picture section on these boxes on the box at the college they represent.

2. Questions

Bayard: these are intended to be used in the future? If we are putting up our photos for prospective schools, can we choose what photo to put up?

- oleary: yes, you can choose.
- how will you hold representatives accountable?
- Bond: it seemed more pertinent to make the legislation, but we can write redbook amendments if needed.
- Burnett: locations—if we have one in each of the colleges, where will they go? Knowing the college of fine arts, we have the school of music on one side of campus, etc. we are very spread out. How would you equitably distribute the remaining 10 boxes?
- Oleary: we have heat maps of where the most high traffic areas are. We will decide where the best places to put them are, but we will let you decide as representatives are. Everything will be spaced out for the floating boxes—we have 7 locations we are looking at for those. We have extra in case we want to put them in special places for limited time, or locations that have not been built yet. We are in talks about how we are going to weight them internally so people cannot steal them, but we want to be able to adjust as needed.
- **Bond:** a poster can be used in place of boxes as well.
- **Locke:** you have a lot of statistics from UVU, but do you have anything on how often they are used? Are people actually making comments? And, I am confused why they are so expensive. Why do they cost so much?
- Bond: when they were first implemented, they were used a lot. Their suggestion boxes were mistaken for recycling bins. We won't have that issue. UVU is rewrapping them in vinyl and moving them around, but we can learn from their mistakes.
- **Bond:** one of the reasons we used UVU—they have more students than us, and we have a captive audience. They don't. we have people who live on campus, but they don't. They are doing better at engagement even though they do not have people in their community on campus. Us producing these boxes will be cheaper than us buying these boxes.
- **Dong:** how will we be aware if students are staying accountable? How are we going to keep track of students who are responding to these, and representatives recognizing they are in charge of these responsibilities?
- Oleary: we are tacitly agreeing to this as something we want to do. This is boosting our profile on campus and increasing our engagement on campus. In ECAB, we will be making sure that people check their assigned boxes. I didn't put redbook into the bill because, by voting for this, we are adding ways to get feedback. By having an easier way or a high profile way of getting feedback, this is another way to do that.
- **Dong:** I know we said that representatives are in charge of boxes, but who will be analyzing this data?
- **Bond**: amber will be handling the QR code. Papers might be put into an excel spreadsheet. Without redbook legislation, we are not sure.
- **Oleary:** we might keep them in the office. It is a method of collecting feedback for your college. We should have a way of counting that. Physical paper we can keep in the office.
- **Reese:** why not entirely online?
- **Bond:** it is to make sure people have access. Not all people have phones or tech to engage entirely online. Student platforms are easy to ignore. Feedback is often viewed as totally optional. Our only consistent presence is in the office.
- **Reese:** will there be clarification on what ECAB does and what legislature does?
- **Oleary:** the insertable picture frame is double sided. One side will show reps with contact information and names. The other side will be executive cabinet. This gives us room to change up what we have. in bright bold lettering, we will have ASUU on the boxes. Anything can be changed if you put your mind to it.
- **Bond:** having a lot of student representation is a valuable chip when it comes to bargaining and negotiations. We need student voices.
- **Burke:** people have to respond within a week, but if I don't have enough time to respond, what do we do? How do we make sure everything is responded to?

- **Oleary:** it doesn't have to be a week. Regular business time response. We put it in there as a suggestion.
- **Burnett:** how big are the boxes?
- **Bond:** waste height.
- **Burnett:** is there a way we can minimize the size of the box? Or make some sort of poster?
- **Bond:** that would put us back in the territory of UVU. We want to be seen and acknowledged. People won't see it otherwise. Accessibility issues as well.

Debate

- **Kotter:** I would recommend adding into the bill a provision for posters for the satellite campuses in places where we canot get those boxes. There is a satellite campus for st. George, but it is important for a presence for ASUU. This is in the scope now.
- **Foley:** that can be passed separately. You can add clauses and sent to reconciliation committee.
- **Munot:** I get the idea behind the boxes and it makes sense, but I am not sure how everyone would feel. But QR codes could have pretty much the same effect. Most peple have phones.
- **Kotter:** I think that there is a big problem ith people on campus not knowing what ASUU can do for them or even knowing that it exists. We need to do something to get in people's faces. Use our help.
- **Oleary:** totally valid. We are trying to be visible. People are QR coded out. We want to bring ASUU to them. This is one way of doing that. We want to increase our visibility and make a new system of doing that.
- **Johnson:** I understand the concerns, but I honestly think it is well thought out and planned, especially accessibility wise. They thought about everyone being able to see and find it. What if we added braille? Just one suggestion.
- **Bond:** I am communicating with a department to put that in a request.
- **Burnett:** as far as visibility and accessibility to students on campus, I recognize that peple are in favor of this, but I am not. If we can allow for tabling at installments of these boxes, this might be more effective—interact with a person instead of a box. Have opportunities throughout the year for students to be represented throughout the year.
- **Reese:** I just want to clarify something in the bill—how much is being spent?
- **Bond:** if we have money left over, that money will be returned to the presidential operating budget.
- **Oguz:** I just want to say, for those who have negative emotions towards this—something that addresses every student is something we should not be stingy about. All of us working in accordance can allow us to have an impact on every campus across Utah.
